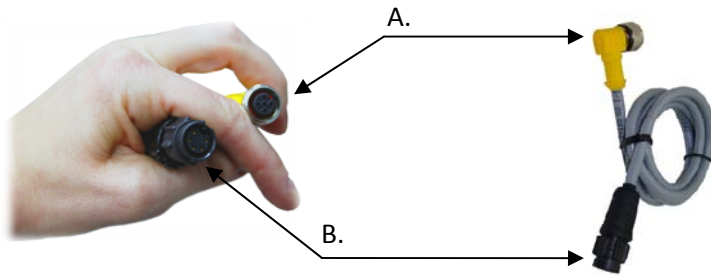


Installation Guide for AgCam Camera to C1000 Monitor Adaptor Cable

1. Dakota Micro, Inc and AGCO PN: **AC-A1C**.
2. This adaptor cable is 60" long.
3. This adaptor cables allows for the input of one (1) AgCam camera into an AGCO C1000 monitor; available in model year 2010-2013, MF 8600 Series, AGCO DT-B series, and Challenger C-Series.

Please Note: Most, not all, 2013 and newer models do not require this adaptor cable as the AgCam adaptor cable is built into the armrest. Please double check your equipment.

4. This adaptor cable can **only** be used with PAL AgCam cameras (PAL AgCam's are black).
5. The adaptor cable looks like this:



- A. 5-pin Female Turck Connector
- B. 5-pin Female Switchcraft Connector

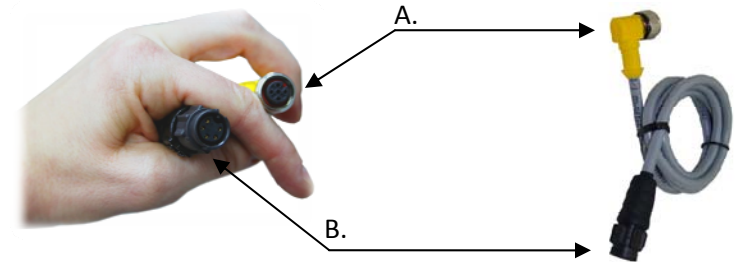
6. How to connect the adaptor cable:
 - a. First, locate the plastic cover on the back of the AGCO C1000 monitor. This cover is held on with four (4) Torx screws. Remove the plastic cover and set aside.
 - b. Second, remove the screws holding the monitor to the armrest. **Please note:** This step cannot be skipped; the 5-pin female Turck connector will not connect fully if the monitor is not temporarily removed.
 - c. Third, attach the adaptor cable to the monitor and reattach the monitor to the armrest.
 - d. If desired, before the monitor is reattached to the armrest, the newly installed adaptor cable can be ran through the armrest and the unused, factory installed video cable can be removed.
7. This adaptor cable requires a PAL camera. All PAL AgCam cameras are black for easy identification.
8. As with all our other adaptor cables, warranty on this item is 1 year from date of purchase. The full Dakota Micro warranty is stated on the back side of this insert.
