


### Installation Guide for AgCam Camera to 5-pin Male M12 Adaptor Cable

1. Dakota Micro, Inc PN: **AC-FDT01**. AGCO PN: **DAC-FDTO1**.
2. This adaptor cable is 40" long.
3. This adaptor cable allows for the input of a single (1) AgCam camera into a Fendt VarioTerminal, AGCO Global cabs and John Deere S-Series Combines, Cotton Pickers & Sprayers.
4. This adaptor will also work with an OverView camera by using a Dakota Micro, Inc. OverView Camera to AgCam Monitor Adaptor Cable (PN: **DMAC-OVC**).
5. The adaptor cable looks like this:

B. 5-pin Male M12 Connector

#### Fendt:

The Tier 4i 700, 800, & 900 Series, Com III and newer tractors have two (2) camera inputs located behind the right hand arm rest (The camera inputs may be covered by protective caps.) Tier 2 700 & 800 Series tractors have a single (1) camera input. This is located on the right hand side of the inside cab.


AGCO Global cabs are offered video ready and non-video ready. Video ready cabs do not need this adaptor cables. Non-video ready AGCO Global cabs are equipped with two (2) camera inputs located on the back of the arm rest that will utilize the AC-FDT01 adaptor cable.

#### John Deere

2017 & 2018 Pre wired "video ready" Combine, Sprayer and Cotton picker cabs are equipped with three (3) camera inputs. These inputs are located: 1) on the end of the auger spout 2) on the rear (top) of the combine and 3) in the hopper.

### Installation Guide for AgCam Camera to 5-pin Male M12 Adaptor Cable

1. Dakota Micro, Inc PN: **AC-FDT01**. AGCO PN: **DAC-FDTO1**.
2. This adaptor cable is 40" long.
3. This adaptor cable allows for the input of a single (1) AgCam camera into a Fendt VarioTerminal, AGCO Global cabs and John Deere S-Series Combines, Cotton Pickers & Sprayers.
4. This adaptor will also work with an OverView camera by using a Dakota Micro, Inc. OverView Camera to AgCam Monitor Adaptor Cable (PN: **DMAC-OVC**).

#### Fendt:

The Tier 4i 700, 800, & 900 Series, Com III and newer tractors have two (2) camera inputs located behind the right hand arm rest (The camera inputs may be covered by protective caps.) Tier 2 700 & 800 Series tractors have a single (1) camera input. This is located on the right hand side of the inside cab.

AGCO Global cabs are offered video ready and non-video ready. Video ready cabs do not need this adaptor cables. Non-video ready AGCO Global cabs are equipped with two (2) camera inputs located on the back of the arm rest that will utilize the AC-FDT01 adaptor cable.

#### John Deere

2017 & 2018 Pre wired "video ready" Combine, Sprayer and Cotton picker cabs are equipped with three (3) camera inputs. These inputs are located: 1) on the end of the auger spout 2) on the rear (top) of the combine and 3) in the hopper.
