# AgCam®/EnduraCam®/RazerCam™ 6' Shielded Power Video Flex with EN3 Female Panel

#### Installation Instructions

- 1. Using a 5/8" drill bit, make a hole in your equipment in the location that you will be inserting the adapter cable.
- 2. If the threads are not long enough to go through your equipment use a 7/8" drill bit to drop sink the connector into the equipment.
- 3. Apply a VERY THIN SMEAR of automotive silicone adhesive around the rim of the hole on the side that you are inserting the connector into, making sure to not get any on the threads when the connector is inserted.
- 4. Insert the female end (A) through the hole; you may need to "wiggle" it a bit, but this ensures a tight fit.
- 5. REMEMBER, the female connector (A) is the side that the camera/extension cable will be attaching to. For cab Installation; the cable length will be inside the cab. For air tank installation the cable length will be outside the
- 6. Attach the dust cap (B) and thread lock nut (C).
- \*Allow 2 hours before use for silicone to set.

In addition to the five (5) years for AgCam® /EnduraCam® cameras Dakota Micro will warranty for the life of the camera against any variety of ingress within the camera housing. This includes moisture and dust particles that are found inside the camera resulting from a manufacturing defect and does not include ingress because of damage caused by no fault of Dakota Micro, Inc.

The Dakota Micro, Inc. limited warranty periods outlined above apply throughout the United States and Canada only. A one (1) year maximum limited warranty for all Products applies to all other geographic locations unless otherwise stated in writing by Dakota Micro. Inc.

This limited warranty does not apply to any issues connected with appearance that have no relation to the performance of the Product nor to any Product the exterior of which has been damaged or defaced, which has been subjected to improper voltage or other misuse, abnormal service or handling, or which has been altered or modified in design or construction.

In order to enforce the rights under this limited warranty, the purchaser should follow the process set forth in the Product Warranty/Repair Process, and provide proof of purchase to Dakota Micro. Inc.

Neither the sales personnel of Dakota Micro, Inc. nor any dealer or any other person is authorized to make any warranties other than those described herein, or to extend the duration of any warranties beyond the time periods described herein.
